Discussion on Proposed TIF Districts

- **Ronnie Lucas** introduced the main topic: the status of proposed TIF districts, focusing on infrastructure improvements and related project costs.
- **Kristy Lesley** provided a detailed review of each area and related costs, with input from ODOT (Oklahoma Department of Transportation).

Infrastructure Improvements and Related Costs

Key Points Discussed:

- **On-Ramp Width Increase**: Proposal to increase the width of the on-ramp to prevent trucks from blocking traffic.
- **Future Congestion**: Addressing potential congestion issues around McDonald's and Joe Don's by redoing the entire loop to facilitate smoother traffic flow.
- **Cost Estimates**: Initial estimates were lower than expected, but considerations for inflation and engineering costs were discussed.
- **Drainage Issues**: Need for proper drainage when adding concrete on the hill to prevent water runoff issues.
- **Priority Areas**: Emphasis on prioritizing the north side of I-40 due to existing businesses and potential new developments.

Comments and Questions

- **Roger Thompson**: Raised concerns about the projected revenue and the need for a 100% share of the TIF revenue.
- Randy Stubblefield: Expressed concerns about the financial burden on the county.
- Andrew Benson: Expressed concerns about the fairness of providing incentives to new businesses over existing ones.
