RESOLUTION NO. 2025 - 10 - CITY

A RESOLUTION OF THE CITY OF OKEMAH, OKLAHOMA, AUTHORIZING AND DIRECTING THE CITY MANAGER TO REQUEST THE RECLASSIFICATION OF THE ZONING DISTRICT CLASSIFICATION OF THE HEREINAFTER DESCRIBED PROPERTIES AS R-5, HIGH DENSITY RESIDENTIAL DISTRICT.

WHEREAS, the City of Okemah supports Midwest Housing Initiative's request for tax credit support from the Oklahoma Housing Finance Agency and affirms that the proposed site will be appropriately zoned prior to the November, 2025, Regular Meeting of the City Council;

WHEREAS the City Council of the City of Okemah, Oklahoma, believes that the following described properties should be reclassified as R-5, High Density Residential District, to-wit:
